



Can I own the car at 1 the end of the lease?

Depending on the type of Novated Lease initially selected, your employee can certainly opt to own the vehicle. If a Finance Lease, has been chosen, they can offer to purchase the vehicle for the agreed residual value. or perhaps sell it and enter a new lease arrangement. With an Operating Lease, they can simply hand the vehicle back with the keys, and are free to upgrade to a new car on a new lease. Smart, right!
