

Even a second-hand car can be leased if it's under a certain age and mileage. Just check with us first and we'll let you know if a pre-loved vehicle satisfies the necessary conditions. A package takes out all the fuss of running your new car by bundling the costs into one easy regular payment. This can cover insurance, registration, maintenance and tyre management, fuel, breakdown assistance, and 24/7 accident management. We recommend that you download the Custom Fleet **Drive App** on your smart phone. It's a great way to access key contacts and important information about your vehicle. Our app helps you keep track of budget, report a lost, stolen or damaged Fleet Card, and easily find your nearest fuel outlet or repair centre. You can also do all your budgeting and find key info through our Fleet Office online portal. Or for everything you need to know about driving and maintaining your vehicle, click the Driver Support tab at customfleet.com.au

In general, it's fairly evenly split. There are those who want the option to own their car outright at the end of the lease term (Budgeted Finance Lease). While others prefer to return the leased car without any further financial obligations (Fully Maintained Operating Lease) and maybe start afresh with a new car. The average term is 3 years, but you can choose up to 5 years for either leasing type.

We always practise transparency so you can be confident that there are no surprises when taking out a Novated Lease with us. Whenever you purchase a new car, however, there are some taxes involved and we can help you make the best choices to minimise their impact - from reducing Fringe Benefits Tax, to removing GST altogether from the purchase price of your car. We suggest you seek independent financial advice prior to leasing.

You can save on fuel with Fleet Card which is accepted at over 6,000 participating multi-branded service stations around Australia. Your Fleet Card will arrive within 7-10 to working days of your lease being activated. Just search for your nearest service station via the Driver Support merchant locator tool on **customfleet.com.au**

If you have left or are planning to leave your employer, it is necessary to notify Custom Fleet as soon as possible. The novated agreement with your employer will cease once you leave your company. You will then be responsible for making all lease payments directly to Custom Fleet, or there may be other arrangements available. Please contact us on 1800 811 922 for more details to discuss how we can best help you move forward.

You certainly can, but it depends on the type of Novated Lease you initially selected. If you have chosen a Finance Lease, you may offer to purchase your vehicle for the agreed residual value, or perhaps sell it and enter a new lease arrangement. With an Operating Lease, simply hand your vehicle back with the keys, and you're free to upgrade to a new car on a new lease. Smart, right!
